To be a Sponsor at Bridgefest 2024, you are agreeing that:

- *The sponsor shall be responsible for its own accident, liability and workers compensation insurance coverages. The sponsor will be responsible to provide a **Certificate of Insurance** which shall be sent with this sponsorship form and naming the Bridgelight, LLC and Calvary Chapel of Old Bridge as an additional insured signing a waiver releasing both of liability. (If you don't have this you will need to sign a waiver.)*
- *A non-refundable deposit of 50% is due within one week of your approval to be a sponsor at Bridgefest.*
- **The remaining 50% is due by June 10th, 2024.**
- *As a sponsor you will bring your own table, tent and chairs. (A representative from your business is responsible for monitoring your table.)*
- *All distribution of literature or merchandise sales must be limited to your specified area.*
- *As a sponsor you will set up and break down at the appointed times*
 - *Arrive and unload between 8am – 9am on Friday*
 - **Food Vendors only will need to arrive by 7:30am on Friday**
 - *Please have your tables manned by 9:00am on Saturday*
 - *Breakdown begins at 5:00pm Saturday*
- **This is a RAIN or SHINE event. As a sponsor you accept full responsibility for your tent and all merchandise.** *Your tent space can remain set up overnight Friday, June 28th as there will be 24-hour security provided, but be sure to pack up your contents and store underneath your table.*
- *Remove all trash at the conclusion of each day.*
- **Initial all pages and sign the attached Agreement and Code of Conduct.**

SPONSORSHIP CODE OF CONDUCT

The principals in the Code of Conduct as set forth by the Bridgelight LLC and Calvary Chapel of Old Bridge state the expectations for its Sponsors on identified business practices.

In selecting sponsors, the Bridgelight LLC and Calvary Chapel of Old Bridge seek to do business with reputable business partners who are committed to ethical standards and business practices compatible with those of the Bridgelight LLC and Calvary Chapel of Old Bridge. This Code applies to all sponsors of the Bridgelight LLC and Calvary Chapel of Old Bridge.

The Bridgelight LLC and Calvary Chapel of Old Bridge strongly encourage sponsors to exceed the requirements of this Code and promote best practices and continuous improvement throughout their operations.

The Bridgelight LLC and Calvary Chapel of Old Bridge expects its sponsors to act responsibly in all respects and to ensure that no abusive, exploitative or illegal conditions exist in their practices.

The Bridgelight LLC and Calvary Chapel of Old Bridge require that Sponsors comply with all applicable laws and regulations, as well as the principles set out in the Code. Where there is no local legal requirement, or if a local legal requirement is not as strict as the requirements included in this Code, The Bridgelight LLC and Calvary Chapel of Old Bridge Sponsors are required to follow the requirements in this Code.

The Bridgelight LLC and Calvary Chapel of Old Bridge's Sponsors are vital business partners, and together, these principles provide us with an opportunity to better the lives of the people we touch.

All Sponsors will comply with the following Code of Conduct:

- I. Sponsors may not engage in any action or practice in violation of local laws or regulations of any country or other location in which it does business. This includes, but is not limited to, laws and regulations related to labor, immigration, health and safety, and the environment.

- II. Child, indentured, involuntary, or prison labor must not be used or supported.

- III. Workers may not be exposed to unreasonably hazardous, unsafe, or unhealthy conditions. The factory shall comply with all applicable laws and regulations.

- IV. Workers may not be unlawfully discriminated against on the basis of race, color, religion, gender, national origin, age, disability or sexual orientation.
- V. The workplace must be free from harassment, which includes coercive, threatening, abusive, or exploitative conduct or behavior or harassment because of one's race, color, religion, gender, national origin, age, disability or sexual orientation.
- VI. Workers have the right, without penalty, to join workers' organizations including unions and political affiliations.
- VII. Workers, at all times, must be treated fairly, with dignity and respect.
- VIII. Wages paid to workers must meet or exceed legal and industry standards. Any overtime should be paid at a premium rate and should be consensual.
- IX. All workers performing work within the country of production must be legally authorized to work in the said country under the applicable local laws. Prior to each worker's assignment, the sponsor must require and review documentation proving such work authorization.
- X. Sponsor may not engage in any conduct likely, intending, or appearing to improperly influence any of the Bridgelight LLC and Calvary Chapel of Old Bridge representatives in the performance of their job responsibilities. Bribes, cash payments, and business gifts and entertainment of more than token value are expressly prohibited. Sponsor must refrain from engaging in any conduct that may appear improper or may result in a conflict of interest when viewed from the Bridgelight LLC and Calvary Chapel of Old Bridge's point of view.
- XI. Sponsor must comply with the provisions of the U.S. Foreign Corrupt Practices Act of 1977, as amended. Sponsor will not offer or provide money or anything else of value to any agent or representative of any government or government agency in order to obtain or retain business.
- XII. Sponsor will act with reasonable diligence to ensure that any of its contractors, subcontractors, manufacturing facilities, labor providers, agents, agencies, associations, distributors, partner organizations, suppliers, affiliated companies, or subsidiaries, who are involved in the Bridgelight LLC and Calvary Chapel of Old Bridge business, also complies with this Code of Conduct.
